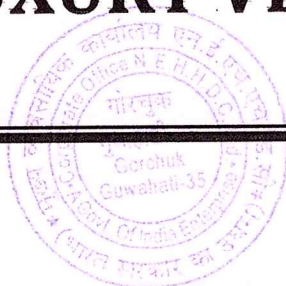

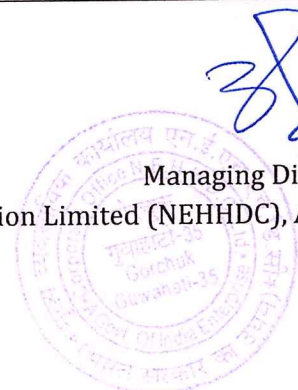

North Eastern Handicrafts and Handlooms Development Corporation Limited (NEHHDC), a CPSE under M/O DONER, Assam invites proposals from experienced, competent and reputed Firms/Agencies/Organizations/ Tourist Operators for empanelment of "AGENCIES" for 'CRAFT TOURISM' on behalf of North Eastern Handicrafts and Handlooms Development Corporation Limited (NEHHDC), Garchuk, Pamohi Road, Assam for a period of two (02) year with the provision of extending for another one (01) year based upon his satisfactory performance and at the discretion of Competent Authority.

The interested bidders are requested to submit their rates in sealed-cover envelopes, superscripted "Request for Quotation" for selection of 'AGENCIES' for promotion of 'CRAFT TOURISM' **through two (02) nos. of Luxury Traveller vehicles** addressed to the undersigned.

The sealed cover envelopes should be in two parts "Technical Bid" and "Price Bid". The sealed cover envelopes written as " Technical Bid" and " Price Bid" should be put in a common single envelope which should be under sealed- cover and superscripted "Request for Quotation for selection of 'AGENCIES' for promotion of 'CRAFT TOURISM' **through two (02) nos. of Luxury Traveller vehicles**"

The sealed bid should be dropped in the tender-box kept at the office of North Eastern Handicrafts & Handlooms Corporation Limited, Garchuk, Guwahati, Assam on or before **30.06.2025 (1:00 PM)**

The bids will be opened on the same day at 03.00 p.m in the presence of such bidders or their authorized representatives who may wish to be present. An authorization letter in company's letter head to this effect must be accompanied with the authorized representative, if the case may be and at the office of North Eastern Handicrafts & Handlooms Corporation Limited, Garchuk campus, Assam on or before the opening of the quotations **30.06.2025 (3:00 PM)**

The bids which are not complete in all respects and having cuttings and overwriting, are liable to be rejected. The Corporation reserves the right to reject or accept all or any bid whole or in part, assigning reasons thereof.

Scope of Work:

To promote crafts of North East India through " Crafts tourism for the people visiting North Eastern Region of India (Assam, Meghalaya, Arunachal Pradesh) through two(02) nos. of Luxury Tourist (Traveller) vehicles owned by NEHHDC. The bidders will promote the works of the weavers related to handicrafts and handlooms sector of NE states through the tourist who visits NE states through them.

To promote crafts of North East India through " Crafts tourism for the people visiting North Eastern Region of India (Assam, Meghalaya, Arunachal Pradesh) through two(02) nos. of Luxury Tourist (Traveller) vehicles owned by NEHHDC. The bidders will promote the works of the weavers related to handicrafts and handlooms sector of NE states through the tourist who visits NE states through them.

The selected agency will be responsible for operating and managing two (02) luxury tourist (Traveller) vehicles owned by NEHHDC to promote the traditional crafts of North East India through a specialized craft tourism program. The initiative aims to create immersive cultural experiences for tourists by facilitating visits to handloom and handicraft clusters, artisan villages, and cultural landmarks of North East Region. The agency will design and implement well-structured tour itineraries that include live demonstrations, interactive sessions with weavers and artisans, hands-on craft experiences, and opportunities for direct

purchases of traditional products. The agency is also expected to handle tourist bookings, offer pre- and post-tour assistance, and ensure high levels of customer satisfaction which helps in promoting regional crafts and local languages to ensure culturally rich and informative tours. Furthermore, the agency will be responsible for branding and promoting NEHHDC's initiatives, documenting each tour through photographs and videos, and submitting monthly reports detailing tour metrics, artisan engagement, tourist feedback, and craft promotion outcomes. This initiative supports NEHHDC's broader mission to empower artisans, enhance market access, and strengthen the linkage between tourism and the craft sector in North East India.

The intending bidders have to pay monthly rentals to NEHHDC for utilizing the two (02) nos of vehicles on the terms & conditions as will be fixed by North Eastern Handicrafts and Handlooms Development Corporation Limited (NEHHDC), Assam.

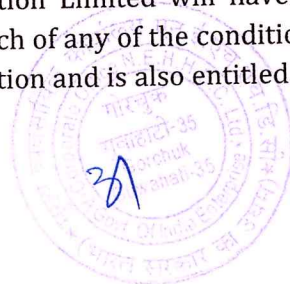
The intending bidder have the liberty to have a physical look of the two vehicles on the following dates which are presently parked at the campus of the office of North Eastern Handicrafts and Handlooms Corporations (NEHHDC), Garchuk, Pamohi Road, Guwahati, Assam.

Date: 23.06.2025 & 24.06.2025

The statutory certificates such as PUC, Insurance, State permits, etc will have to made up to date, if got lapsed at the time of handing over the vehicle to the successful bidder/bidders and have to be maintained in an up to date manner by the successful bidder/bidders throughout the contract period, however the cost of which will be reimbursed by NEHHDC to the party(Successful bidder/bidders).

A. General Conditions

1. The RFQ documents can be downloaded from the website of North Eastern Handicrafts and Handlooms Corporation Limited.
2. Sealed Cover tenders addressed to **Managing Director (MD), North Eastern Handicrafts and Handlooms Corporation Limited, Guwahati, Assam** must be submitted on or before **30.06.2025 (1:00 PM)**
3. The proposals shall be submitted in the following manner and shall contain details/documents as listed below:
 - i. Forwarding letter on the letter head of the firm/organization.
 - ii. A complete set of the bid documents along-with all other supporting documents duly filled and signed by the authorized signatory of the firm/organization with the official seal of the organization/firm etc.
 - iii. In case the proposals being submitted by a partnership firm it must be signed by each partner thereof or in the event of the absence of any partner, it must be signed on his behalf by a person holding a power of attorney authorizing him to do so.
 - iv. An Index page showing contents/annexure & page no. should be annexed first followed by relevant documents with proper page numbering & signed by the owner of the firm or his Authorized Signatory as token of acceptance of Terms & Conditions. In case the proposals are signed by any Authorized signatory, a copy of the power of attorney/ authorization letter (in company's letter head) is to be enclosed along with Bid.
 - v. It shall be ensured that every page of bid document is duly numbered and signed with seal of the bidder without any cutting and over writing.
4. Falsification/suppression of information shall lead to disqualification of the bidder / cancellation of contract even after award of work during the currency of the contract.
5. Tenders received after the prescribed time and date will not be considered.
6. Conditional tenders will not be accepted and will be summarily rejected.
7. The bidder must ensure that the conditions laid down for submission of offers are complete and correctly filled. Over writing of bids will be treated as cancelled.
8. Any changes/modification with respect to this RFQ will be duly notified in our official website.
9. It shall be ensured that every page of RFQ document is duly numbered and signed with seal of the bidder without any cutting and over writing.
10. North Eastern Handicrafts and Handlooms Corporation Limited will have the option to terminate the contract if the bidder commits the breach of any of the conditions confined in this RFQ and fails to render the services to its satisfaction and is also entitled to recover any losses from the bills as submitted to NEHHDC.



11. The contractor/firms/organizations shall comply with the legal bindings required to carry out the requisite works and shall obtain the necessary licenses and permits at his/her own cost.
12. In case of any labour/employee problems related to the workmen staff of the vendor, the same will be settled at the vendor's end only.
13. It will be the contractor's responsibility to ensure that the obligations under the terms of this contract are duly performed and observed.
14. The contractor shall not use North Eastern Handicrafts and Handlooms Corporation Limited address on his letter-head/ stationery for purposes of Registration with any Government/Local Body or any other organization or person and no tenancy shall be created by the presence of his workmen/employee on North Eastern Handicrafts and Handlooms Corporation Limited premises.
15. The vendor shall remove any employee immediately for engagement with NEHHDC without any cross question who in the opinion of North Eastern Handicrafts and Handlooms Corporation Limited is guilty of misconduct, or is in any manner unfit or unsuitable for service.
16. Track record of bidder should be clean and should not have any involvement in illegal activities or financial frauds. There should not be any case with the Police/Court/Regulatory authorities against the bidder.
17. The vendor/firm should not assign or sublet the empanelment or any part or it to any other vendor/firm in any form. Such actions shall result in termination of empanelment
18. North Eastern Handicrafts and Handlooms Corporation Limited reserves the right to reject any or all of the tenders received without assigning any reason thereof.
19. The participating bidders will have to deposit a non refundable "Tender Fees" of Rupees 500/- (Five Hundred) only plus 18% GST in the form of Demand Draft/Banker Cheque drawn in favour of "**North Eastern Handicrafts and Handlooms Corporation Limited**" payable at Guwahati. However, Micro and Small Enterprises (MSE) registered under department of Micro, Small and Medium Enterprises (MSME) are exempted from depositing the EMD amount.
20. The participating bidders will be required to deposit an amount of Rupees 39000/- (Thirty Nine Thousand) in the form of EMD amount through Demand Draft/Banker Cheque drawn in favour of "**North Eastern Handicrafts and Handlooms Corporation Limited**" payable at Guwahati.
21. Micro and Small Enterprises (MSE) registered under department of Micro, Small and Medium Enterprises (MSME) are exempted from depositing the EMD amount.
22. The bank draft/banker cheque deposited as EMD amount of the unsuccessful bidder will be returned to them on submission of a written application to MD, NEHHDC
23. **The selected party/parties will have to deposit Performance Security Deposit of Rs.96000 /- (Rupees Ninety Six Thousand) only as a security deposit by means of a Demand Draft/Banker Cheque drawn in favour of "North Eastern Handicrafts and Handlooms Corporation Limited" payable at Guwahati, which will be held by NEHHDC until the contract ends.**
24. The security deposit may be adjusted with the EMD amount of successful bidder at the request of the bidder. In such a case, the EMD money of the successful bidder will be treated as Security Deposit and the successful bidder will have to deposit balance amount The security deposit shall be **returned within sixty (60) days upon contract completion**, provided clearance of all financial obligations.
25. NEHHDC is not responsible/ accountable for any commission amount deducted by Bank for

- the purpose of issuance of Bank draft or any other similar documents.
26. The participating bidders will have to submit an affidavit (Notarized) as per Annexure IV to the effect that the firm has not been blacklisted by any other Central Government/State Government Department/PSUs and that no criminal case/complaint is pending against them anywhere in India.
 27. **Any corrigendum, clarification, amendment, or notification related to this RFQ shall be published only on the official website of NEHHDC at www.nehhdc.com. Interested bidders are advised to regularly visit the website for updates.**
 28. **Any dispute arising out of the contract will be settled under the Guwahati Jurisdiction.**

B. Basic Requisite eligibility documents:

1. The Bidder shall be a legally registered entity in India.
2. Article of memorandum of association or partnership deed or affidavit of the sole proprietorship deed as the case may be.
3. Copy of valid up to date Trade License or equivalent specific to the job.
4. Copy of the GST registration certificate
5. Photocopy of I.T PAN card (In the name of firm/proprietor/partners etc)
6. Non-Black Listed certificate
7. CA certified statement showing the average annual turnover of the bidders be at least Rs 06 (six) lakhs in India during last three financial years i.e. for the year ending March 31, 2021-22, 2022-23, and 2023-24
8. The Party should have minimum at-least five (05) years of experience in the business of dealing/management of fleet of vehicles through tourism sector by catering the tourist visiting North East India.

All the copies of documents should be self-attested by the bidder with full signature.

C. Specific Terms and conditions

While submission of the bid, the bidder have to consider the following specific terms & conditions which the selected bidder will have to comply without fail while utilizing the two vehicles for promotion of craft tourism.

1. Submission of financial quote:

- The **intending bidder will have to quote** an amount as a monthly **hiring fee** (Rupees only) for the two vehicles separately against the RFQ and the bidder quoting the highest rate and who get qualified in the Technical bid will be considered as H1 bidder and will be awarded the work.
- If any intending bidder wishes to quote for a single vehicle, he has the liberty to quote for a single vehicle; however in that case also the bidder who quotes the highest rate for that vehicle and who gets technically qualified will be awarded the work.
- The vendor to whom the work will be awarded will be responsible for installation of GPS tracker in the vehicle/vehicles and the cost related to installation of GPS tracker and its maintenance will be borne by the vendor till the contract period ends.

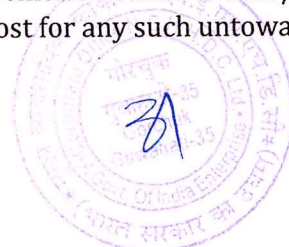
- **The consideration of H1 bidder will be determined independently against each vehicle.**

2. Maintenance & Expenses

- The Periodic maintenance (Periodic servicing) of the vehicles must be carried out in an **"authorized service centre"** after **every four(04) months or every 10000-12000 kms, whichever is earlier**. The documentary evidence of such periodic maintenance of the vehicles must be submitted in the office of NEHHDC, Garchuk, Guwahati, Assam.
- Failing to comply with such "periodic maintenance" of the vehicle will result in withholding all pending and future bills along -with the amount of security deposit.
- Any damage to the vehicles resulting in non compliance of such periodic maintenance of the vehicles will be recovered from the amount of security deposit and any pending/future bills.
- The amount of periodic maintenance cost that is to be borne by the successful bidder (H1 bidder) is capped to Rs 10000/- on each occasion of such periodic maintenance. Any amount up and above the capped amount of Rs 10000/- will be borne by NEHHDC on each occasion of periodic servicing.
- The periodic maintenance will include all the requisite activities such as change of engine oil, lubricant oil etc or change/replacement of any other parts as may be required for proper maintenance of the vehicle as per the vehicle manufacture's norms.
- The cost of replacement of the old tyre with new tyre of the vehicles as and when required as per vehicle manufacture's norms will have to be borne by the successful bidder to whom the work will be awarded (H1 bidder). NEHHDC will not bear the cost of new tyre of both the vehicles. The documentary evidence of replacement of the old tyre with new tyre must be submitted to NEHHDC.
- **Routine maintenance** (puncture repairs, washing, minor running repairs etc) up to Rs.5000/- per month will be borne by the **selected party/parties to whom the work will be awarded**.
- Any **extra maintenance cost exceeding Rs. 5000/- per month** will be borne by NEHHDC upon submission of a proper bill by NEHHDC.

3. Legal & Regulatory Compliance

- NEHHDC will bear the costs of **road tax, insurance, fitness, permits and other periodic regulatory expenses** of the vehicles and provide **Photostat copies** of documents to the **party to whom the work will be awarded**.
- Any **modifications** to the vehicle for tourist purposes require **explicit written permission** from NEHHDC and must comply with **RTO/MVI approval and government norms**.
- The party/bidder will be solely responsible for any violation of any traffic rules during the contract period that may arise while operating the vehicles.
- The party/bidder will be responsible for any untoward incident such as accidents etc during the contract period that may arise while operating the vehicles and the bidder/party will be solely responsible for repair of the vehicles at his own cost for any such untoward incidents.



4. **Driver & Marketing Responsibilities**

- The **successful bidder/Party** to whom the work will be awarded will be solely responsible for paying the **salary/remuneration** of the **driver/handyman** of the vehicle.

5. **Prohibited Use**

- The **successful bidder/ Party** shall **not engage the vehicle in any illegal activities and the vehicle shall be explicitly utilized for handloom & handicraft promotion (craft promotion) through tourism and catering to the tourists only. The successful bidder/ Party in any circumstances cannot sublet the work he is awarded against this RFQ.**

D. **Pre-mature Termination of Registration**

Premature termination of registration of vendor may be done with the approval of competent authority on unsatisfactory performance:

- A. Vendor is declared bankrupt or insolvent or its financial position has become unsound,.
- B. Vendor fails to furnish Income Tax Clearance Certificate or any other document when called for.
- C. The integrity of vendor is suspected. Blacklisting of firm can be done on the recommendations of the Competent Official.
- D. North Eastern Handlooms & Handicrafts Corporation Limited (NEHHDC) will have the right to terminate the contract if the contractor commits the breach of any of the conditions confined in this tender document and fails to render the services to the satisfaction of North Eastern Handlooms & Handicrafts Corporation Limited (NEHHDC).

E. **Selection Criteria**

Based on the proposal/bids as received by North Eastern Handlooms & Handicrafts Corporation Limited (NEHHDC), it will select the most appropriate/eligible and deserving vendor in line with the requirement and suitability of NEHHDC. The selection criteria for selection of the vendor will be done on the basis of Highest Cost Basis Method (HCB) of tendering. i.e the bidder who quote the **highest rate (Without Tax)** and who gets technically qualified will be awarded the work.

In the first stage of evaluation process, only **Technical Bid** of the bidders will be opened. Those bidders satisfying the technical requirements as determined by NEHHDC and accepting the terms and conditions of these documents shall be short-listed. The decision in this regard will be at the sole discretion of NEHHDC. **Under Technical Evaluation the bidder satisfying all the conditions/submission of documents as mentioned in this tender document will only be considered as technically qualified.**

Under the second stage of evaluation process, **Price Bid** of only those bidders who have been short-listed earlier in first stage (Technical Evaluation) will be opened.
