Battle of backwardness: Apex court

Reserves Order On Sub-Classifying Quota After Three Days Of Hearing

 $\textbf{New Delhi:} \ \textbf{Supreme Court's}$ seven-judge bench on Thursday reserved its verdict on a bunch of petitions seeking overruling of the court's 2004 judgment precluding subclassification of communities categorised as Scheduled Castes to provide a larger quota benefits to the weakest groups among Dalits.

"It is a battle of backwardness within the backward communities," said CJI D Y Chandrachud, who led a bench also comprising Justice BR Gavai, and the lone Dalit judge on the bench, and Justices Vikram Nath, Bela M Trivedi, Pankaj Mithal, Manoj Misra and Satish Chandra Mishra.

In 2004, a five-judge bench in the EV Chinnaiah case had held SC communities to be a homogeneous group which could not be sub-classified and struck down an Andhra Pradesh law of 2000 which provided for sub-categorisation in the larger category. Later, a 2006 Punjab law on the same lines was struck down

by the HC citing the Chinnaiah judgment.

However, the bench indicated that it would only determine whether the ruling in Chinnaiah case, that is no sub-classification of communities according to the degree of their backwardness, was correct or not. It clarified that the court would not go into the validity of state-enacted laws sub-classifying communities among SCs for graded distribution of the 15% quota for Dalits, It said HCs concerned would determine validity of sub-classification laws passed by states after scrutinising the quantifiable empirical data about backwardness of a community available with the legislature to allot a certain percentage of quota to those most backward

among SC communities. The seven-judge bench gave ample indication of where its prima facie iudicial views rested as it remarked on the unintended discrimination inflicted on communities within Scheduled Castes that when socially and educationally advanced groups among them cornered a larger share

of quota benefits at the cost of other sections, thus negating equal opportunity in access to education and government

Those opposed to sub-classification of SCs, through senior advocates Manoj Swarup, K S Chauhan, Sanjay Hegde and others, argued that the common thread for inclusion of communities in the SC list was their social discrimination and denial of basic rights for centuries.

The CJI said, "That is true but what else is common between the groups. Is the discri-

mination faced by them similar? There are many important indicators — access to education and government jobs, marriageable age, infant mortality, maternity mortality rate. Do all groups suffer identically on these aspects?

Explaining the CJI's view, Justice Gavai said, "Both blacksmiths and scavengers are included in the SC list. But did these two groups face similar discrimination? There are untouchables among the untouchables. Should they all be treated as equals in terms of access to education and jobs? To achieve equality, states are required to be permitted to provide graded quota benefits to the more oppressed communities among

"If a particular community corners 75% of seats reserved for SCs, leaving a minuscule number of posts for other Dalit communities. should the state be barred from sub-classifying the quota for a more equitable distribution of reservation to achieve social equality mandated under Articles 15 and 16 of the Constitution?

Scheduled Castes.

Justice Gavai said in 1985. he was the lawver for a candidate belonging to Mehtar (sweeper) community who was waging a legal battle to get an MBBS seat, which was unfairly denied to him.

"Not a single person from that community had become a doctor even 35 years after the country became a republic," he added.

The CJI said the landmark Indira Sawhney judgment of 1992, which gave 27% reservation to other backward classes (OBCs), had also adopted the principle of sub-classification of backward among the backwards and this concept had not been altered by subsequent constitutional amendments.

During the three-day hearing, the shortest in terms of a seven-judge constitution bench tasked to reconsider the ruling of a five-judge bench, application of 'creamy layer' principle to eliminate the advanced among the backward from cornering quota benefits was touched upon briefly by Justice Gavai who said some kind of filtration was necessary.

Supreme Court says 'bail, not jail' rule not applicable in UAPA cases

New Delhi: In an important ruling, SC has held that conventional idea of 'bail is the rule, jail is the exception' is not applicable when an accused is facing charges under anti-terror law UAPA and, also, that delayed trial proceedings in grave offences could be a ground to seek bail.

Delineating Section 43D(5) of Unlawful Activities (Prevention) Act, a bench of Justices M M Sundresh and Aravind Kumar said that wording of the provision is in contrast with wording of bail provision under Section 437(1) of Criminal Procedure Code, indicating that for UAPA, the

legislature's intent was to make bail, the exception and iail, the rule.

"The conventional idea in bail jurisprudence vis-à-vis ordinary penal offences that the discretion of courts must tilt in favour of the oft-quoted phrase — 'bail is the rule, jail is the exception' — unless circumstances justify otherwise

- does not find any place while dealing with bail applications under UAPA. The 'exercise' of the general power to grant bail under UAPA is severely restrictive in scope. The form of the words used in proviso to Section 43D (5) — 'shall not be released' in contrast with the form of the words as found in Section 437 (1) CrPC — 'may be released' – suggests the intention of the legislature to make bail, the exception and jail, the rule,' the court said in a case concerning the 'Sikhs for Justice',

of which Pannun isa member. The bench said that law has placed stringent conditions for bail and there is no question to grant relief if there are reasonable grounds to believe that the accusation against a person for committing offence under UAPA is prima facie true

"In this background, the

test for rejection of bail is

quite plain. Bail must be rejected as a 'rule', if after hearing the prosecutor and after perusing the final report or case diary, the court arrives at a conclusion that there are reasonable grounds for believing that the accusations are prima facie true. It is only if the test for rejection of bail is not satisfied - the courts would proceed to decide bail application in accordance with the 'tripod test' (flight risk, influencing witnesses, tampering with evidence),'
