

#### 8. Process Description.

Color Removal System works in three stages:-

- I) Flocculation and Settling
- II) Ion Exchange Process
- III) Chlorination

## Flocculation and Settling:-

In this stage dye or color in colloidal is removed. Small dye particles in the effluent are coagulated by using polyelectroyte and coagulant at higher pH. This is then passed through a tube settler where coagulated dye settles down and clearer water flows up. Dye is taken out from the hopper bottom of tube settler in the form of a thick sludge. Clear water is further treated in the second stage.

# Ion Exchange Process:-

A special grade resin is used to take out the removing color. This resin selectively exchanges organic compounds. Since all dyes are organic in nature, the dye in dissolved form (which is not removed in stage I) is removed by this resin. The water coming out of this unit is 100% free of color. To bring COD & BOD within PCB limits chlorination is carried out. Around 80-90% color in the effluent from textile processing units is removed in stage I. Removing 10-20% is removed in the second stage.

#### Cholorination:-

A doser after the CRU doses chlorine in the treated water. This ensures oxidation and thus removes COD.
